Rules of participation in a competition 'Grants for young researchers and doctoral students' at the Institute of Mathematics of the Polish Academy of Sciences

awarded thanks to the statutory subsidy for conducting research fostering development of young scientists and doctoral students

§1

The competition 'grants for young researchers' is open for researchers employed at IMPAN who on the day of submission of the application are under the age of 35, and meet the following requirements:

- 1. have been employed in IMPAN for at least 6 months in a given calendar year,
- 2. submit the application (application form in Annex 1 to the Rules of Participation) together with description of the project and work schedule within a specified deadline,
- 3. enclose a positive opinion of the head of a research unit in which they are employed, or of another individual researcher employed at IMPAN,
- 4. enclose their publication record.

§2

The competition 'grants for doctoral students' is open for doctoral students studying at IMPAN, beginning from the second year of doctoral studies, and who meet the following requirements:

- 1. submit the application (application form in Annex 1 to the Rules of Participation) together with description of the project and work schedule within a specified deadline,
- 2. have registered for the PhD conferment procedure at IMPAN, or enclose a conspectus of a doctoral dissertation accepted by their scientific supervisor,
- 3. enclose a positive opinion of their scientific supervisor together with the evaluation of the progress of the doctoral dissertation,
- 4. enclose their publication record.

§3

- 1. The resources accorded for grants mentioned in §1 and §2 may be used to subsidize travels related to the doctoral studies or research activity conducted at IMPAN, e.g. schools, scientific workshops, delivering a lecture strictly related to the doctoral dissertation or research activity, language courses, or other expenses related to the conducted research activity.
- 2. The grants may also cover salaries for the best young researchers and doctoral students.

3. The condition for settling grants for young researchers and grants for doctoral students is submission of a report (template in Annex 2) in which an employee or a doctoral student will present the way he or she has used the awarded financial resources.

§4

All applicants to the competition are required to submit a declaration with their consent for the processing of their personal data to the extent necessary for competition proceedings.

§5

When announcing the competition, the Director of IMPAN specifies the application deadline, specific conditions, and appoints the competition Committee.

§6

The grant termination involves submitting a relevant financial settlement and report (template in Annex 2) not later than 15 December of the year when the grant was awarded.
