# Representation formulae for $\left(C_{0}\right) m$-parameter operator semigroups

#### Abstract

Some general representation formulae for $\left(C_{0}\right) m$-parameter operator semigroups with rates of convergence are obtained by the probabilistic approach and multiplier enlargement method. These cover all known representation formulae for $\left(C_{0}\right)$ one- and $m$ parameter operator semigroups as special cases. When we consider special semigroups we recover well-known convergence theorems for multivariate approximation operators.


1. Introduction. Recently the study of representation formulae for ( $C_{0}$ ) operator semigroups has attracted much attention (Shaw [17, 18], ButzerHahn [2], Pfeifer [13-15] and Chen-Zhou [3]). They gave some general formulae that include earlier (Post-Widder, Hille-Phillips [8] and Chung [4]) concrete representation formulae. But most of the work done so far is confined to the one-parameter case, while Shaw's method for the multi-parameter case is not an easy one to get new formulae and the results are without rates of convergence. In this article we try to give some general representation formulae for $\left(C_{0}\right) m$-parameter operator semigroups. The main idea is the use of a probabilistic setting in the representation of operator semigroups, initiated by Chung [4] and developed by Butzer-Hahn [2] and Pfeifer [13], and the so-called multiplier enlargement method of Hsu-Wang [9, 19] and Shaw $[17,18]$. At the same time, by introducing a modified second modulus of continuity of an operator semigroup and a Steklov-type element we establish quantitative estimates of the obtained formulae.

To the best of our knowledge, all existing representation formulae for $\left(C_{0}\right)$ one- and multi-parameter operator semigroups are special cases of our results. In particular, Shaw's formulae [17, 18] for $m$-parameter operator

[^0]semigroups are special cases of our results when specifying the random vectors considered. Also with our method it is easier to obtain new formulae.

At the end we give examples to show the application of our results in multivariate operator approximation theory when we consider particular operator semigroups.
2. Preliminaries. Let $\mathcal{X}$ be a Banach space with norm $\|\cdot\|$, and $\mathcal{E}(\mathcal{X})$ be the Banach algebra of endomorphisms of $\mathcal{X}$. If $T \in \mathcal{E}(\mathcal{X}),\|T\|$ also denotes the norm of $T$. Let $\mathbb{R}^{m}$ be the $m$-dimensional Euclidean space supplied with the usual definition of arithmetical operations and metric. We write $t=\left(t_{1}, \ldots, t_{m}\right) \in \mathbb{R}^{m}, \bar{t}=t_{1}+\ldots+t_{m},|t|=\left|t_{1}\right|+\ldots+\left|t_{m}\right|$ and denote the unit vectors by $e_{1}, \ldots, e_{m}$, where $e_{k}=(0, \ldots, 1, \ldots, 0)$ with 1 in the $k$ th place and 0 elsewhere. Further, let

the first closed $2^{m}$-ant in $\mathbb{R}^{m} . \mathbb{Z}_{+}$denotes the set of all non-negative integers and

while $\mathbb{N}$ is the set of all positive integers.
A family of bounded linear operators $\left\{T(t): t \in \mathcal{R}_{+}^{m}\right\}$ on $\mathcal{X}$ is called a $\left(C_{0}\right)$ m-parameter operator semigroup in $\mathcal{E}(\mathcal{X})$ when the following three conditions are satisfied:

It is known that $\left\{T(t): t \in \mathbb{R}_{+}^{m}\right\}$ is then the direct product of $m\left(C_{0}\right)$ one-parameter operator semigroups in $\mathcal{E}(\mathcal{X})$ :

where $T_{k}\left(t_{k}\right)=T\left(t_{k} e_{k}\right)$. The operators $\left\{T_{k}\left(t_{k}\right): 0 \leq t_{k}<\infty\right\}(k=$ $1, \ldots, m)$ commute with each other.

Let $A_{k}$ be the infinitesimal generator of $\left\{T_{k}\left(t_{k}\right): 0 \leq t_{k}<\infty\right\}$ with domain $D\left(A_{k}\right), k=1, \ldots, m$. Then if $f$ is in $D\left(A_{k}\right)$ so is $T(t) f$ for each $t \in \mathbb{R}_{+}^{m}$ and

Further, if $f \in D\left(A_{j}\right)$ and $f \in D\left(A_{j} A_{k}\right)$ then $f \in D\left(A_{k} A_{j}\right)$ and $A_{k} A_{j} f=A_{j} A_{k} f(j, k=1, \ldots, m)$. In the following we use the notation

$D^{2}$ is a linear subspace of $\mathcal{X}$.
To each $k=1, \ldots, m$, there correspond two numbers $M_{k} \geq 1$ and $\omega_{k} \geq 0$ such that

Hence we have the inequality

where $M=M_{1} \ldots M_{m}$ and $\omega=\max \left\{\omega_{k}: 1 \leq k \leq m\right\}$.
In the following it is always understood that $\left\{T(t): t \in \mathbb{R}_{+}^{m}\right\}$ satisfies (5), unless otherwise specified.

For the above definitions and properties of operator semigroups we refer to Butzer-Berens [1], Hille-Phillips [8] or W. Köhnen [11].

Let $(\Omega, \mathcal{A}, P)$ be a probability space. For every real-valued random variable $X$ defined on $(\Omega, \mathcal{A}, P), E(X)$ denotes its expectation. If $\xi=E(X)$ exists then $\sigma^{2}=\sigma^{2}(X)=E\left[(X-\xi)^{2}\right]$ is the variance of $X$. Let further $\Psi_{X}(u)=E\left(u^{X}\right), u \geq 0$, and $\Psi_{X}^{*}(u)=E\left(e^{u X}\right), u \in \mathbb{R}$, denote the probability-generating function and the moment-generating function of $X$ respectively.

We need to consider $m$-dimensional random vectors, also denoted by $X, Y, \ldots$, on $(\Omega, \mathcal{A}, P)$. For an $m$-dimensional random vector $X=\left(X_{01}, \ldots\right.$, $X_{0 m}$ ), we also use $E(X)$ to denote its expectation:

It is not difficult to extend the theory of the extended Pettis integral developed in [13] to the multivariate case.

Let $\left\{T(t): t \in \mathbb{R}_{+}^{m}\right\}$ be as above and $X$ be an $\mathbb{R}_{+}^{m}$-valued random vector such that

Then for every $f \in \mathcal{X}$ define

which exists in the Bochner sense in $\mathcal{X}$ by the strong continuity of $\{T(t)$ : $\left.t \in \mathbb{R}_{+}^{m}\right\}$ and (5). Moreover, the map $E[T(X)]: f \rightarrow E[T(X) f]$ on $\mathcal{X}$ defines a bounded linear operator $E[T(X)] \in \mathcal{E}(\mathcal{X})$ with

$E[T(X)]$ is called the expectation of $T(X)$ and is understood as an extended Pettis integral following [13].

If $X$ and $Y$ are independent $\mathbb{R}_{+}^{m}$-valued random vectors such that $\Psi_{\bar{X}}^{*}(\omega)$ $<\infty$ and $\Psi_{\bar{Y}}^{*}(\omega)<\infty$ then $E[T(X)], E[T(Y)]$ and $E[T(X+Y)]$ exist in $\mathcal{E}(\mathcal{X})$ and

where " $\circ$ " denotes composition.
For the above see [13], [15], [16] and the references cited there.
3. Auxiliary results. We need a Taylor expansion integral formula for $\left(C_{0}\right) m$-parameter operator semigroups.

Lemma 1. Assume $\left\{T(t): t \in \mathbb{R}_{+}^{m}\right\}$ is a $\left(C_{0}\right)$ m-parameter operator semigroup satisfying (5). Then for every $g \in D^{2}$ and $s, t \in \mathbb{R}_{+}^{m}$,
(6) $T(t) g-T(s) g$

Proof. Let $G(u)=T(s+u(t-s)) g \in \mathcal{X}, u \in[0,1]$. Then

Now (6) follows from the Taylor formula with integral remainder for Banach space valued functions (see, e.g., [5, Theorem 8.14.3]).

For our purpose we need a second modulus of continuity $\omega_{2}(T f, \delta)$ and the Steklov operator $J_{h}(f)(h>0)$ for a $\left(C_{0}\right) m$-parameter operator semigroup $\left\{T(t): t \in \mathbb{R}_{+}^{m}\right\}$ and $f \in \mathcal{X}$.

Definition 1.

We have $\omega_{2}(T f, \delta) \rightarrow 0$ as $\delta \rightarrow 0$, by the strong continuity of $\left\{T(t): t \in \mathbb{R}_{+}^{m}\right\}$.

## Definition 2.

The integral may be considered as a multi- $\mathcal{X}$-valued Riemann integral.
We have the following lemma:
Lemma 2. (i) $J_{h}(f) \in D^{2}$ for all $f \in \mathcal{X}$;
(ii) $\left\|f-J_{h}(f)\right\| \leq \omega_{2}(T f, h)$;
(iii) $\left\|A_{i} A_{j} J_{h}(f)\right\| \leq 9 M e^{2(m-1) h \omega} \omega_{2}(T f, h) / h^{2}, 1 \leq i, j \leq m$.

Proof. (i) Let

It is not difficult to show that $J_{1} \in D^{2}, J_{2} \in D^{2}$ (cf. [1, p. 10]) and hence (i) holds.
(ii) We have

(iii) When $i \neq j$, similar to the one-parameter operator semigroup case (ibid.), we can show

Lemma 3. For any $\mathbb{R}_{+}^{m}$-valued random vector $Y=\left(Y_{01}, \ldots, Y_{0 m}\right)$ with $E(Y)=x=\left(x_{1}, \ldots, x_{m}\right)$ and $f \in \mathcal{X}$,

Therefore by (11)-(14) we get (9).

4. Main results. Here comes our first main result:

I_{1} \leq 2^{1 / q} \frac{4 q^{2}}{e^{2} \tau} d_{3}^{1 / q}
$$

and

I_{2}=\gamma_{i}^{2}\left(E\left(\left(\frac{1}{\tau} N_{\tau}-\eta\right)^{2 q}\right)\right)^{1 / q} \leq \gamma_{i}^{2} d_{2} / \tau
$$

Therefore by inequality (9) of Lemma 3 for $Y=Y_{\tau}$ and $h=1 / \sqrt{\tau}$, we get

&\left.\times 2 \sum_{i=1}^{m}\left[2^{1 / q}\left(\frac{4 q^{2}}{e^{2} \tau} d_{3}^{1 / q}\right)+d_{2} \frac{\gamma_{i}^{2}}{\tau}\right] \tau\right\} \\
&= M \omega_{2}(T f, 1 / \sqrt{\tau})\left\{2 d_{1}+9 m M e^{2 \omega \eta \bar{\gamma}} e^{2(m-1) \omega / \sqrt{\tau}} d_{1}^{1 / p}\right. \\
&\left.\times\left[m 2^{1 / q}\left(\frac{2 q}{e}\right)^{2} d_{3}^{1 / q}+d_{2} \sum_{i=1}^{m} \gamma_{i}^{2}\right]\right\}
\end{aligned}
$$

If $\omega=0$, we apply inequality (10) of Lemma 3. Note that

\begin{aligned}
\sigma^{2}\left(Y_{0 i}\right) & =\sigma^{2}\left(\frac{1}{\tau} \sum_{k=1}^{N_{\tau}} X_{k i}\right)=\frac{1}{\tau^{2}} \sum_{l=0}^{\infty} P\left(N_{\tau}=l\right) E\left(\left(\sum_{k=1}^{l} X_{k i}\right)^{2}\right)-\eta^{2} \gamma_{i}^{2} \\
& =\frac{1}{\tau^{2}} \sum_{l=0}^{\infty} P\left(N_{\tau}=l\right)\left(l E\left(X_{0 i}^{2}\right)+l(l-1) \gamma_{i}^{2}\right)-\eta^{2} \gamma_{i}^{2}
\end{aligned}
$$

$$
\begin{aligned}
& =\frac{1}{\tau^{2}} E\left(N_{\tau}\right) E\left(X_{0 i}^{2}\right)+\frac{1}{\tau^{2}}\left(E\left(N_{\tau}^{2}\right)\right) \gamma_{i}^{2}-\frac{1}{\tau^{2}}\left(E\left(N_{\tau}\right)\right) \gamma_{i}^{2}-\eta^{2} \gamma_{i}^{2} \\
& =\frac{1}{\tau}\left[\eta \sigma^{2}\left(X_{0 i}\right)+\gamma_{i}^{2} \frac{1}{\tau} \sigma^{2}\left(N_{\tau}\right)\right] .
\end{aligned}
$$

By (10), when $h=1 / \sqrt{\tau}$, we obtain (25).
Another generalization of Theorem 1 is presented next.
Theorem 4. Let $N=\left(N_{1}, \ldots, N_{m}\right)$ be a $\mathbb{Z}_{+}^{m}$-valued random vector with $E(N)=\eta=\left(\eta_{1}, \ldots, \eta_{m}\right)$. For each $i(1 \leq i \leq m)$, let $\left\{Y_{k i}\right\}_{k=1}^{\infty}$ be a sequence of i.i.d. real-valued random variables distributed as $Y$, a fixed random variable with $E(Y)=\gamma . N$ and $Y_{k i}$ are assumed to be independent. Also assume that there exists a $\delta>0$ such that

Then for $n>\max \left(p \omega / \delta, 1 / \delta^{2}\right)$,

& \leq 2 M \omega_{2}(T f, 1 / \sqrt{n})\left\{e^{\omega \gamma \bar{\eta}} \exp \left[\frac{2 n \omega^{2}}{e^{2}(n \delta-\omega)^{2}} \Psi_{\bar{N}}\left(\Psi_{Y}^{*}(\delta)\right)\right]\right. \\
&+2^{1 / q} 9 M \frac{m^{2} q^{2}}{e^{2}} e^{3 \omega \gamma \bar{n}} e^{2(m-1) \omega / \sqrt{n}} \\
&\left.\times \exp \left[\left(\frac{2 n p \omega^{2}}{e^{2}(n \delta-p \omega)^{2}}+\frac{2 n e^{\delta \gamma \bar{\eta}}}{e^{2} q(\delta \sqrt{n}-1)^{2}}\right) \Psi_{\bar{N}}\left(\Psi_{Y}^{*}(\delta)\right)\right]\right\}
\end{align*}
$$

where $p, q>0,1 / p+1 / q=1$, is an arbitrary conjugate pair. If $\omega=0$, then

& \left\|\left\{E\left[T\left(\sum_{k_{1}=1}^{N_{1}} \frac{1}{n} Y_{k_{1} 1}, \ldots, \sum_{k_{m}=1}^{N_{m}} \frac{1}{n} Y_{k_{m} m}\right)\right]\right\}^{n} f-T(\gamma \eta) f\right\|  \tag{27}\\
& \quad \leq 2 M \omega_{2}(T f, 1 / \sqrt{n})\left\{1+\frac{9}{4} m M \sum_{i=1}^{m}\left[\eta_{i} \sigma^{2}(Y)+\sigma^{2}\left(N_{i}\right) \gamma^{2}\right]\right\} .
\end{align*}

Proof. In Theorem 1, take $X:=\left(\sum_{k_{1}=1}^{N_{1}} Y_{k_{1} 1}, \ldots, \sum_{k_{m}=1}^{N_{m}} Y_{k_{m} m}\right)$ and let $X_{k} \stackrel{\text { i.i.d. }}{\sim} X$. Then

We observe that

& =E\left(e^{\delta\left(\Sigma_{k_{1}=1}^{N_{1}} Y_{k_{1} 1}+\ldots+\Sigma_{k_{m}=1}^{N_{m}} Y_{k_{m} m}\right)}\right) \\
& =\sum_{l_{1}=0}^{\infty} \ldots \sum_{l_{m}=0}^{\infty} P\left(N=\left(l_{1}, \ldots, l_{m}\right)\right) E\left(e^{\delta \Sigma_{k_{1}=1}^{l_{1}} Y_{k_{1} 1}+\ldots+\delta \Sigma_{k_{m}=1}^{l_{m}} Y_{k_{m} m}}\right) \\
& =\sum_{l_{1}=0}^{\infty} \ldots \sum_{l_{m}=0}^{\infty} P\left(N=\left(l_{1}, \ldots, l_{m}\right)\right) E\left(e^{\delta \Sigma_{k_{1}=1}^{l_{1}} Y_{k_{1} 1}}\right) \ldots E\left(e^{\delta \Sigma_{k_{m}=1}^{l_{m}} Y_{k_{m} m}}\right) \\
& =\sum_{l_{1}=0}^{\infty} \ldots \sum_{l_{m}=0}^{\infty} P\left(N=\left(l_{1}, \ldots, l_{m}\right)\right)\left(E\left(e^{\delta Y}\right)\right)^{l_{1}} \ldots\left(E\left(e^{\delta Y}\right)\right)^{l_{m}} \\
& =\sum_{l_{1}=0}^{\infty} \ldots \sum_{l_{m}=0}^{\infty} P\left(N=\left(l_{1}, \ldots, l_{m}\right)\right)\left(E\left(e^{\delta Y}\right)\right)^{l_{1}+\ldots+l_{m}} \\
& =E\left(\left(E\left(e^{\delta Y}\right)\right)^{N_{1}+\ldots+N_{m}}\right)=\Psi_{\bar{N}}\left(\Psi_{Y}^{*}(\delta)\right) .
\end{aligned}
$$

Thus (26) follows from (15).
If $\omega=0$ we see that

established similarly to the fact at the end of the proof of Theorem 2. Now (27) follows from (16).
5. Further results: multiplier enlargement formulae. In this section we modify the formulae obtained in the previous section by the so-called multiplier enlargement method (see [6]) initiated by Hsu-Wang [9, 19] in the 60 's and also used by Shaw [17, 18] in the representation of operator semigroups. The modified representation formulae have a larger range of applications and when we specify the random vectors (variables) considered, we recover the representation formulae for $m$-parameter operator semigroups of Shaw [18]. For simplicity we only consider equibounded operator semigroups, i.e.,

\|T(t)\| \leq M \quad \text { for all } t \in \mathbb{R}_{+}^{m}
$$

Here we only need to give two versions related to Theorems 1 and 4. Others can be similarly obtained.

Theorem 5. Suppose $\|T(t)\| \leq M$ for all $t \in \mathbb{R}_{+}^{m}$, and $\alpha_{n}$ is a sequence of positive real numbers with $\liminf _{n \rightarrow \infty} \alpha_{n}>0$. For each $n \in \mathbb{N}$ let $X(n)$ be an $\mathbb{R}_{+}^{m}$-valued random vector with $E[X(n)]=x / \alpha_{n}$. Assume
$\limsup _{n \rightarrow \infty} \alpha_{n} \sigma_{i}^{2}(X(n))<\infty, i=1, \ldots, m$. Then

$$
\begin{align*}
& \left\|\left\{E\left[T\left(\frac{\alpha_{n}}{n} X(n)\right)\right]\right\}^{n} f-T(x) f\right\|  \tag{28}\\
& \quad \leq 2 M \omega_{2}\left(T f,\left(\alpha_{n} / n\right)^{1 / 2}\right)\left[1+\frac{9}{4} m M \alpha_{n} \sum_{i=1}^{m} \sigma_{i}^{2}(X(n))\right]
\end{align*}
$$

Proof. For each fixed $n$, let $X_{k} \stackrel{\text { i.i.d. }}{\sim} X(n), k=1, \ldots, n$, and consider

Y:=\frac{1}{n} \sum_{k=1}^{n} \alpha_{n} X_{k} .
$$

Then

E[T(Y)] f=E\left[T\left(\frac{1}{n} \sum_{k=1}^{n} \alpha_{n} X_{k}\right)\right] f=\left\{E\left[T\left(\frac{\alpha_{n}}{n} X(n)\right)\right]\right\}^{n} f

Furthermore,

\sigma_{i}^{2}(Y)=\sigma_{i}^{2}\left(\frac{1}{n} \sum_{k=1}^{n} \alpha_{n} X_{k}\right)=\frac{\alpha_{n}^{2}}{n^{2}} n \sigma_{i}^{2}(X(n))=\frac{\alpha_{n}^{2}}{n} \sigma_{i}^{2}(X(n))
$$

Now take $h=\left(\alpha_{n} / n\right)^{1 / 2}$; then by (10), we get (28).
Theorem 6. Let $\alpha_{n}$ be a sequence of positive real numbers satisfying

For each $n \in \mathbb{N}$, let $N(n):=\left(N_{1}(n), \ldots, N_{m}(n)\right)$ be a $\mathbb{Z}_{+}^{m}$-valued random vector with $E(N(n))=\left(1 / \alpha_{n}\right) \eta=\left(1 / \alpha_{n}\right)\left(\eta_{1}, \ldots, \eta_{m}\right)$ and

$$
\limsup _{n \rightarrow \infty} \alpha_{n} \sigma_{i}^{2}(N(n))<\infty \quad \text { for all } i=1, \ldots, m
$$

For each $i(1 \leq i \leq m)$, let $\left\{Y_{k i}(n)\right\}_{k=1}^{\infty}$ be a sequence of i.i.d. random variables, distributed as $Y(n)$, where $Y(n)$ is a fixed real-valued random variable for each $n \in \mathbb{N}$ and $E(Y(n))=\alpha_{n} \gamma$. Suppose that $Y_{0 i}(n)(i=$ $1, \ldots, m)$ and $N(n)$ are all independent. Assume also that

\limsup _{n \rightarrow \infty} \sigma^{2}(Y(n)) / \alpha_{n}^{2}<\infty
$$

Consider the equibounded operator semigroup $\left\{T(t): t \in \mathbb{R}_{+}^{m}\right\}$ with

$$

Then
(29)

\begin{aligned}
& \text { (29) } \quad\left\|\left\{E\left[T\left(\sum_{k_{1}=1}^{N_{1}(n)} \frac{1}{n} Y_{k_{1} 1}(n), \ldots, \sum_{k_{m}=1}^{N_{m}(n)} \frac{1}{n} Y_{k_{m} m}(n)\right)\right]\right\}^{n} f-T(\gamma \eta) f\right\| \\
& \leq 2 M \omega_{2}\left(T f,\left(\alpha_{n} / n\right)^{1 / 2}\right)\left\{1+\frac{9}{4} m M \sum_{i=1}^{m}\left[\frac{\eta_{i}}{\alpha_{n}^{2}} \sigma^{2}(Y(n))+\gamma^{2} \alpha_{n} \sigma_{i}^{2}(N(n))\right]\right\} .
\end{aligned}
$$

Proof. We want to apply Lemma 3. Let

X_{k} \stackrel{\text { i.i.d. }}{\sim} X:=\left(\sum_{k_{1}=1}^{N_{1}(n)} Y_{k_{1} 1}(n), \ldots, \sum_{k_{m}=1}^{N_{m}(n)} Y_{k_{m} m}(n)\right)

Y=\frac{1}{n} \sum_{k=1}^{n} X_{k}
$$

Then

\begin{aligned}
E(Y) & =E(X)=\left(E\left(\sum_{k_{1}=1}^{N_{1}(n)} Y_{k_{1} 1}(n)\right), \ldots, E\left(\sum_{k_{m}=1}^{N_{m}(n)} Y_{k_{m} m}(n)\right)\right) \\
& =\left(\frac{1}{\alpha_{n}} \eta_{1} \alpha_{n} \gamma, \ldots, \frac{1}{\alpha_{n}} \eta_{m} \alpha_{n} \gamma\right)=\left(\eta_{1} \gamma, \ldots, \eta_{m} \gamma\right)=\gamma \eta .
\end{aligned}
$$

Moreover,

E[T(Y)] f=\left\{E\left[T\left(\sum_{k_{1}=1}^{N_{1}(n)} \frac{1}{n} Y_{k_{1} 1}(n), \ldots, \sum_{k_{m}=1}^{N_{m}(n)} \frac{1}{n} Y_{k_{m} m}(n)\right)\right]\right\}^{n} f .
$$

Furthermore,

\sigma_{i}^{2}(Y) & =\sigma_{i}^{2}\left(\frac{1}{n} \sum_{k=1}^{n} X_{k}\right)=\frac{1}{n} \sigma^{2}\left(\sum_{k_{i}=1}^{N_{i}(n)} Y_{k_{i} i}(n)\right) \\
& =\frac{1}{n}\left[E\left(N_{i}(n)\right) \sigma^{2}\left(Y_{0 i}(n)\right)+\sigma^{2}\left(N_{i}(n)\right)\left(E\left(Y_{0 i}(n)\right)\right)^{2}\right] \\
& =\frac{1}{n}\left[\frac{1}{\alpha_{n}} \eta_{i} \sigma^{2}(Y(n))+\sigma^{2}\left(N_{i}(n)\right) \alpha_{n}^{2} \gamma^{2}\right] .
\end{aligned}
$$

Pick $h:=\left(\alpha_{n} / n\right)^{1 / 2}$; then by (10) of Lemma 3 we have

\left\|\left\{E\left[T\left(\sum_{k_{1}=1}^{N_{1}(n)} \frac{1}{n} Y_{k_{1} 1}(n), \ldots, \sum_{k_{m}=1}^{N_{m}(n)} \frac{1}{n} Y_{k_{m} m}(n)\right)\right]\right\}^{n} f-T(\gamma \eta) f\right\|
$$

$$
\begin{aligned}
\leq & 2 M \omega_{2}\left(T f,\left(\alpha_{n} / n\right)^{1 / 2}\right) \\
& \times\left\{1+\frac{9 m M}{4} \frac{n}{\alpha_{n}} \sum_{i=1}^{m} \frac{1}{n}\left[\frac{1}{\alpha_{n}} \eta_{i} \sigma^{2}\left(Y_{0 i}(n)\right)+\sigma^{2}\left(N_{i}(n)\right) \alpha_{n}^{2} \gamma^{2}\right]\right\} \\
\leq & 2 M \omega_{2}\left(T f,\left(\alpha_{n} / n\right)^{1 / 2}\right) \\
& \times\left\{1+\frac{9}{4} m M \sum_{i=1}^{m}\left[\frac{\eta_{i}}{\alpha_{n}^{2}} \sigma^{2}(Y(n))+\gamma^{2} \alpha_{n} \sigma_{i}^{2}(N(n))\right]\right\} .
\end{aligned}
$$

6. Applications. In this section we specify the random vectors (variables) and $\alpha_{n}$ of Theorems 1-6 to derive some concrete representation formulae for $\left(C_{0}\right) m$-parameter operator semigroups. We also illustrate how to get the results on multivariate approximation operators from the corresponding ones on operator semigroups. Unless otherwise mentioned all $\left(C_{0}\right)$ $m$-parameter operator semigroups considered satisfy (5).

Example 1. Take $X=\left(X_{01}, \ldots, X_{0 m}\right)$ that follows the multi-point distribution with $E X=x=\left(x_{1}, \ldots, x_{m}\right)$ :

$$
P\left(X=e_{i}\right)=x_{i} \quad\left(e_{i}=(0, \ldots, 1, \ldots, 0)\right)
$$

and

$$
P(X=0)=1-\bar{x}, \quad \text { where } 0<\bar{x}<1\left(\bar{x}=x_{1}+\ldots+x_{m}\right) .
$$

Then

$$
\Psi_{\bar{X}}^{*}(\delta)=E\left(e^{\delta \bar{X}}\right)=P(\bar{X}=0)+P(\bar{X}=1) e^{\delta}=1-\bar{x}+\bar{x} e^{\delta}<\infty .
$$

Furthermore, we have

$$
E[T(X / n)]=I+\sum_{i=1}^{m} x_{i}\left(T_{i}(1 / n)-I\right)
$$

Hence by Theorem 1 there is a constant $K=K(\omega, M, x, \delta, m)$ such that

\|\left(I+\sum_{i=1}^{m} x_{i}\left(T_{i}(1 / n)-I\right)\right)^{n} & f-T(x) f \|  \tag{30}\\
& \leq K \omega_{2}(T f, 1 / \sqrt{n}) \rightarrow 0 \quad(n \rightarrow \infty)
\end{array}
$$

From the above result on operator semigroups we are able to recover the approximation theorem for multivariate Bernstein operators as follows. Choose
$\mathcal{X}:=\operatorname{BUC}\left(\mathbb{R}^{m}\right)$
$:=\left\{f: f\right.$ is a bounded uniformly continuous function from $\mathbb{R}^{m}$ into $\left.\mathbb{R}\right\}$ and define

$$
T(t) f(x):=f(x+t)=f\left(x_{1}+t_{1}, \ldots, x_{m}+t_{m}\right)
$$

for each $f \in \mathcal{X}$ and $x \in \mathbb{R}^{m}$. Then $\left\{T(t): t \in \mathbb{R}_{+}^{m}\right\}$ is a $\left(C_{0}\right) m$-parameter operator semigroup in $\mathcal{E}(\mathcal{X})$.

Now let $x=0, t=\left(t_{1}, \ldots, t_{m}\right), 0<\bar{t}<1,0<t_{i}<1, i=1, \ldots, m$. Then

$$
\begin{aligned}
&\left\{I+\sum_{i=1}^{m} t_{i}\left[T_{i}(1 / n)-I\right]\right\}^{n} f(0) \\
&=\sum_{k \in \mathbb{Z}_{+}^{m}, \bar{k} \leq n} f\left(k_{1} / n, \ldots, k_{m} / n\right) \frac{n!}{k_{1}!\ldots k_{m}!\left(n-k_{1}-\ldots-k_{m}\right)!} \\
& \times t_{1}^{k_{1}} \ldots t_{m}^{k_{m}}(1-\bar{t})^{n-\bar{k}} \\
&= B_{n}^{f}\left(t_{1}, \ldots, t_{m}\right)
\end{aligned}
$$

where $B_{n}^{f}\left(t_{1}, \ldots, t_{m}\right)$ is the $m$-variate Bernstein operator over a simplex (cf. [12]). So by (30), we obtain

$$
\lim _{n \rightarrow \infty} B_{n}^{f}\left(t_{1}, \ldots, t_{m}\right)=T(t) f(0)=f\left(t_{1}, \ldots, t_{m}\right), \quad \text { uniformly. }
$$

Remark. The fact that the approximation theorem for the Bernstein operator can be derived from simple operator semigroup considerations has been observed by many authors (see, e.g., [1, p. 28], [10] and [14]). When considering other representation formulae for $m$-parameter operator semigroups in the following examples we may derive other known convergence theorems for multivariate approximation operators, but we avoid to go into details here.

Example 2. Let $\alpha_{n}$ be a sequence of positive real numbers with $\liminf _{n \rightarrow \infty} \alpha_{n}>0$ and $\lim _{n \rightarrow \infty} \alpha_{n} / n=0$. For each $n \in \mathbb{N}$ take $X(n)=$ $\left(X_{01}(n), \ldots, X_{0 m}(n)\right)$ to have a modified multi-point distribution:

P\left(X(n)=e_{i}\right)=x_{i} / \alpha_{n}, \quad 1 \leq i \leq m \\
P(X(n)=0)=1-\bar{x} / \alpha_{n} \quad\left(0<\bar{x} / \alpha_{n}<1 \text { and } x_{i}>0\right) .
\end{gathered}
$$

Then

$$
E[X(n)]=\frac{x}{\alpha_{n}} \quad\left(x=\left(x_{1}, \ldots, x_{m}\right)\right)
$$

and

$$
\sigma_{i}^{2}(X(n))=E\left(X_{i}^{2}(n)\right)-\left(E\left(X_{i}(n)\right)\right)^{2}=\frac{x_{i}}{\alpha_{n}}-\frac{x_{i}^{2}}{\alpha_{n}^{2}} .
$$

For an equibounded $\left(C_{0}\right) m$-parameter operator semigroup $\{T(t): t \in$ $\left.\mathbb{R}_{+}^{m}\right\}$ with $\|T(t)\| \leq M$ for all $t \in \mathbb{R}_{+}^{m}$, we have

$$
\begin{aligned}
E\left[T\left(\frac{\alpha_{n}}{n} X(n)\right)\right] & =T(0) P(X(n)=0)+\sum_{i=1}^{m} T\left(\frac{\alpha_{n}}{n} e_{i}\right) P\left(X(n)=e_{i}\right) \\
& =I+\sum_{i=1}^{m} \frac{x_{i}}{\alpha_{n}}\left(T_{i}\left(\frac{\alpha_{n}}{n}\right)-I\right)
\end{aligned}
$$

Thus by Theorem 5, we obtain

$$
\begin{align*}
& \left\|\left\{I+\sum_{i=1}^{m} \frac{x_{i}}{\alpha_{n}}\left(T_{i}\left(\frac{\alpha_{n}}{n}\right)-I\right)\right\}^{n} f-T(x) f\right\|  \tag{31}\\
\leq & 2 M \omega_{2}\left(T f,\left(\alpha_{n} / n\right)^{1 / 2}\right)\left[1+\frac{9}{4} m M \alpha_{n} \sum_{i=1}^{m}\left(\frac{x_{i}}{\alpha_{n}}-\frac{x_{i}^{2}}{\alpha_{n}^{2}}\right)\right] \\
= & 2 M \omega_{2}\left(T f,\left(\alpha_{n} / n\right)^{1 / 2}\right)\left[1+\frac{9}{4} m M \sum_{i=1}^{m}\left(x_{i}-\frac{x_{i}^{2}}{\alpha_{n}}\right)\right] \rightarrow 0 \quad(n \rightarrow \infty)
\end{align*}
$$

Remark. (30) is the special case of (31) when $\alpha_{n} \equiv 1$, but (30) is true for an arbitrary $\left(C_{0}\right) m$-parameter operator semigroup.

Inequalities (31) and the following (32)-(34) are Shaw's formulae [17, 18] supplied with rates of convergence.

Example 3. Assume $\alpha_{n}$ is as in Example 2. For each $n$, let $X(n):=$ $\left(X_{01}(n), \ldots, X_{0 m}(n)\right)$ follow the negative multi-point distribution:

$$
P\left(X(n)=\left(k_{1}, \ldots, k_{m}\right)\right)=\binom{\bar{k}}{k}\left(1+\frac{1}{\alpha_{n}} \bar{x}\right)^{-1} \prod_{i=1}^{m}\left(\frac{x_{i}}{\alpha_{n}+\bar{x}}\right)^{k_{i}}
$$

for all $k=\left(k_{1}, \ldots, k_{m}\right) \in \mathbb{Z}_{+}^{m}=\left\{\left(n_{1}, \ldots, n_{m}\right): n_{i} \in \mathbb{Z}_{+}, 1 \leq i \leq m\right\}$, where $x=\left(x_{1}, \ldots, x_{m}\right) \in \mathbb{R}_{+}^{m}$ is fixed and

$$
\binom{n}{k}=\frac{n(n-1) \ldots(n-\bar{k}+1)}{k_{1}!\ldots k_{m}!}
$$

Then

$$
P\left(X_{0 i}(n)=k_{i}\right)=\left(1+\frac{1}{\alpha_{n}} x_{i}\right)^{-1}\left(\frac{x_{i}}{\alpha_{n}+x_{i}}\right)^{k_{i}}
$$

(see [7, p. 165, (8.4)]),

$$
E\left(X_{0 i}(n)\right)=\sum_{k_{i}=0}^{\infty} k_{i}\left(1+\frac{1}{\alpha_{n}} x_{i}\right)^{-1}\left(\frac{x_{i}}{\alpha_{n}+x_{i}}\right)^{k_{i}}=\frac{x_{i}}{\alpha_{n}}
$$

and

$$
\sigma_{i}^{2}(X(n))=\frac{x_{i}^{2}}{\alpha_{n}^{2}}+\frac{x_{i}}{\alpha_{n}}
$$

For an equibounded $\left(C_{0}\right) m$-parameter operator semigroup $\{T(t): t \in$ $\left.\mathbb{R}_{+}^{m}\right\}$ with $\|T(t)\| \leq M$ for all $t \in \mathbb{R}_{+}^{m}$, we have

$$
\begin{aligned}
& E\left[T\left(\frac{\alpha_{n}}{n} X(n)\right)\right] \\
&=\sum_{k_{1}=0}^{\infty} \ldots \sum_{k_{m}=0}^{\infty} T\left(\frac{\alpha_{n}}{n}\left(k_{1}, \ldots, k_{m}\right)\right)\binom{\bar{k}}{k}\left(1+\frac{1}{\alpha_{n}} \bar{x}\right)^{-1} \prod_{i=1}^{m}\left(\frac{x_{i}}{\alpha_{n}+\bar{x}}\right)^{k_{i}} \\
&=\sum_{k_{1}=0}^{\infty} \ldots \sum_{k_{m}=0}^{\infty}\binom{\bar{k}}{k}\left(1+\frac{1}{\alpha_{n}} \bar{x}\right)^{-1} \prod_{i=1}^{m}\left(\frac{x_{i} T_{i}\left(\alpha_{n} / n\right)}{\alpha_{n}+\bar{x}}\right)^{k_{i}} \\
&=\left(1+\frac{1}{\alpha_{n}} \bar{x}\right)^{-1}\left[I-\frac{x_{1} T_{1}\left(\alpha_{n} / n\right)+\ldots+x_{m} T_{m}\left(\alpha_{n} / n\right)}{\alpha_{n}+\bar{x}}\right]^{-1} \\
&=\left\{I+\frac{I}{\alpha_{n}} \bar{x}-\frac{x_{1}}{\alpha_{n}} T_{1}\left(\alpha_{n} / n\right)-\ldots-\frac{x_{m}}{\alpha_{n}} T_{m}\left(\alpha_{n} / n\right)\right\}^{-1} \\
&=\left\{I-\sum_{i=1}^{m} \frac{x_{i}}{\alpha_{n}}\left(T_{i}\left(\alpha_{n} / n\right)-I\right)\right\}^{-1} .
\end{aligned}
$$

By Theorem 5 we obtain

$$
\begin{align*}
& \left\|\left\{I-\sum_{i=1}^{m} \frac{x_{i}}{\alpha_{n}}\left(T_{i}\left(\alpha_{n} / n\right)-I\right)\right\}^{-n} f-T(x) f\right\|  \tag{32}\\
\leq & 2 M \omega_{2}\left(T f,\left(\alpha_{n} / n\right)^{1 / 2}\right)\left[1+\frac{9}{4} m M \alpha_{n} \sum_{i=1}^{m}\left(\frac{x_{i}}{\alpha_{n}}+\frac{x_{i}^{2}}{\alpha_{n}^{2}}\right)\right] \\
= & 2 M \omega_{2}\left(T f,\left(\alpha_{n} / n\right)^{1 / 2}\right)\left[1+\frac{9}{4} m M \sum_{i=1}^{m}\left(x_{i}+\frac{x_{i}^{2}}{\alpha_{n}}\right)\right] \rightarrow 0 \quad(n \rightarrow \infty) .
\end{align*}
$$

Example 4. In Theorem 6 take $N(n)$ that follows the multi-point distribution:

$$
\begin{gathered}
P\left(N(n)=e_{i}\right)=x_{i} / \alpha_{n}, \quad 1 \leq i \leq m \\
P(N(n)=0)=1-\bar{x} / \alpha_{n}, \quad \text { where } x=\left(x_{1}, \ldots, x_{m}\right) \in \mathbb{R}_{+}^{m}, \text { is fixed. }
\end{gathered}
$$

Here $\alpha_{n}$ is as in Example 2. Let $Y_{0 i}(n), 1 \leq i \leq m$, be exponentially distributed with density $\left(1 / \alpha_{n}\right) e^{-v / \alpha_{n}}, v \in \mathbb{R}_{+}$. Then

$$
\begin{gathered}
E(N(n))=\frac{1}{\alpha_{n}} x=\left(\frac{1}{\alpha_{n}} x_{1}, \ldots, \frac{1}{\alpha_{n}} x_{m}\right), \quad E\left(Y_{0 i}(n)\right)=\alpha_{n}, \\
\sigma^{2}\left(N_{i}(n)\right)=\frac{x_{i}}{\alpha_{n}}-\frac{x_{i}^{2}}{\alpha_{n}^{2}} \quad \text { and } \quad \sigma^{2}\left(Y_{0 i}(n)\right)=\alpha_{n}^{2} .
\end{gathered}
$$

Also

$$
E\left[T_{i}\left(\frac{1}{n} Y_{0 i}(n)\right)\right]=\int_{0}^{\infty} T_{i}(v / n) \frac{1}{\alpha_{n}} e^{-v / \alpha_{n}} d v=\left(I-\frac{\alpha_{n}}{n} A_{i}\right)^{-1}
$$

(cf. [8, p. 360] and [18, p. 226]).
Furthermore, we have

$$
\begin{aligned}
& E\left[T\left(\sum_{k_{1}=1}^{N_{1}(n)} \frac{1}{n} Y_{k_{1} 1}(n), \ldots, \sum_{k_{m}=1}^{N_{m}(n)} \frac{1}{n} Y_{k_{m} m}(n)\right)\right] \\
& \quad=T(0) P(N(n)=0)+\sum_{i=1}^{m} E\left[T_{i}\left(\frac{1}{n} Y_{k_{i}}(n)\right)\right] P\left(N(n)=e_{i}\right) \\
& \quad=I+\sum_{i=1}^{m} \frac{x_{i}}{\alpha_{n}}\left[\left(I-\frac{\alpha_{n}}{n} A_{i}\right)^{-1}-I\right] .
\end{aligned}
$$

By (29) of Theorem 6 for an equibounded ( $C_{0}$ ) m-parameter operator semigroup $\left\{T(t): t \in \mathbb{R}_{+}^{m}\right\}$ with $\|T(t)\| \leq M$ for all $t \in \mathbb{R}_{+}^{m}$, we get

$$
\begin{align*}
& \quad\left\|\left\{I+\sum_{i=1}^{m}\left(x_{i} / \alpha_{n}\right)\left[\left(I-\frac{\alpha_{n}}{n} A_{i}\right)^{-1}-I\right]\right\}^{n} f-T(x) f\right\|  \tag{33}\\
& \leq 2 M \omega_{2}\left(T f,\left(\alpha_{n} / n\right)^{1 / 2}\right)\left\{1+\frac{9}{4} m M \sum_{i=1}^{m}\left[\frac{x_{i}}{\alpha_{n}^{2}} \alpha_{n}^{2}+\alpha_{n}\left(\frac{x_{i}}{\alpha_{n}}-\frac{x_{i}^{2}}{\alpha_{n}^{2}}\right)\right]\right\} \\
& = \\
& 2 M \omega_{2}\left(T f,\left(\alpha_{n} / n\right)^{1 / 2}\right)\left[1+\frac{9}{4} m M \sum_{i=1}^{m}\left(2 x_{i}-x_{i}^{2} / \alpha_{n}\right)\right] \rightarrow 0 \quad(n \rightarrow \infty) .
\end{align*}
$$

Example 5. Take $\alpha_{n}$ and $Y_{0 i}(n)$ as in Example 4. Let $N(n)$ have the negative multi-point distribution:

$$
P\left(N(n)=\left(l_{1}, \ldots, l_{m}\right)\right)=\binom{\bar{l}}{l}\left(1+\frac{1}{\alpha_{n}} \bar{x}\right)^{-1} \prod_{i=1}^{m}\left(\frac{x_{i}}{\alpha_{n}+\bar{x}}\right)^{l_{i}}
$$

for all $l=\left(l_{1}, \ldots, l_{m}\right) \in \mathbb{Z}_{+}^{m}$, where $x=\left(x_{1}, \ldots, x_{m}\right) \in \mathbb{R}_{+}^{m}$ is fixed. Then

$$
\begin{gathered}
E(N(n))=\frac{1}{\alpha_{n}} x=\left(\frac{1}{\alpha_{n}} x_{1}, \ldots, \frac{1}{\alpha_{n}} x_{m}\right), \quad E\left(Y_{0 i}(n)\right)=\alpha_{n}, \\
\sigma^{2}\left(N_{i}(n)\right)=\frac{x_{i}^{2}}{\alpha_{n}^{2}}+\frac{x_{i}}{\alpha_{n}} \quad \text { and } \quad \sigma^{2}\left(Y_{0 i}(n)\right)=\alpha_{n}^{2} .
\end{gathered}
$$

Furthermore, we observe that

$$
\begin{aligned}
E[T & \left.\left(\sum_{k_{1}=1}^{N_{1}(n)} \frac{1}{n} Y_{k_{1} 1}(n), \ldots, \sum_{k_{m}=1}^{N_{m}(n)} \frac{1}{n} Y_{k_{m} m}(n)\right)\right] \\
& =\sum_{l \in \mathbb{Z}_{+}^{m}} P(N(n)=l) E\left[T\left(\sum_{k_{1}=1}^{l_{1}} \frac{1}{n} Y_{k_{1} 1}(n)\right), \ldots, T\left(\sum_{k_{m}=1}^{l_{m}} \frac{1}{n} Y_{k_{m} m}(n)\right)\right] \\
& =\sum_{l \in \mathbb{Z}_{+}^{m}}\binom{\bar{l}}{l}\left(1+\frac{1}{\alpha_{n}} \bar{x}\right)^{-1} \prod_{i=1}^{m}\left(\frac{x_{i} E\left[T_{i}(Y / n)\right]}{\alpha_{n}+\bar{x}}\right)^{l_{i}} \\
& =\left\{I+\frac{1}{\alpha_{n}} \bar{x} I-\sum_{i=1}^{m} \frac{x_{i}}{\alpha_{n}} E\left[T_{i}(Y / n)\right]\right\}^{-1} \\
& =\left\{I+\frac{1}{\alpha_{n}} \bar{x} I-\sum_{i=1}^{m} \frac{x_{i}}{\alpha_{n}}\left(I-\frac{\alpha_{n}}{n} A_{i}\right)^{-1}\right\}^{-1} \\
& =\left\{I-\sum_{i=1}^{m} \frac{x_{i}}{\alpha_{n}}\left[\left(I-\frac{\alpha_{n}}{n} A_{i}\right)^{-1}-I\right]\right\}^{-1}
\end{aligned}
$$

Thus by (29) of Theorem 6 , for an equibounded $\left(C_{0}\right) m$-parameter operator semigroup $\left\{T(t): t \in \mathbb{R}_{+}^{m}\right\}$ with $\|T(t)\| \leq M$ for all $t \in \mathbb{R}_{+}^{m}$, we have

$$
\begin{align*}
& \quad\left\|\left\{I-\sum_{i=1}^{m} \frac{x_{i}}{\alpha_{n}}\left[\left(I-\frac{\alpha_{n}}{n} A_{i}\right)^{-1}-I\right]\right\}^{-n} f-T(x) f\right\|  \tag{34}\\
& \leq \\
& 2 M \omega_{2}\left(T f,\left(\alpha_{n} / n\right)^{1 / 2}\right)\left\{1+\frac{9}{4} m M \sum_{i=1}^{m}\left[\frac{x_{i}}{\alpha_{n}^{2}} \alpha_{n}^{2}+\alpha_{n}\left(\frac{x_{i}^{2}}{\alpha_{n}^{2}}+\frac{x_{i}}{\alpha_{n}}\right)\right]\right\} \\
& = \\
& 2 M \omega_{2}\left(T f,\left(\alpha_{n} / n\right)^{1 / 2}\right)\left[1+\frac{9}{4} m M \sum_{i=1}^{m}\left(2 x_{i}+\frac{x_{i}^{2}}{\alpha_{n}}\right)\right] \rightarrow 0 \quad(n \rightarrow \infty) .
\end{align*}
$$

Example 6. Take $N$ to be a non-negative integer-valued random variable that follows the geometric distribution over $\mathbb{Z}_{+}$:
$P(N=k)=\frac{1}{1+\eta}\left(\frac{\eta}{1+\eta}\right)^{k} \quad$ for all $k \in \mathbb{Z}_{+}$, where $\eta>0$ is a parameter.
Let also $Y \equiv\left(x_{1}, \ldots, x_{m}\right) \in \mathbb{R}_{+}^{m}$. Then

$$
E(N)=\eta>0, \quad E Y \equiv\left(x_{1}, \ldots, x_{m}\right)=x
$$

Furthermore,

$$
\Psi_{N}\left(\Psi_{\bar{X}}^{*}(\delta)\right)=E\left(e^{\delta\left(x_{1}+\ldots+x_{m}\right) N}\right)=\frac{1}{1+\eta-e^{\delta\left(x_{1}+\ldots+x_{m}\right)} \eta}<\infty
$$

for $\delta<(1 / \bar{x}) \ln (1+1 / \eta)$. So by Theorem 2 , there is a constant $K=$
$K(M, \omega, \delta, \eta, x)$ such that for sufficiently large $n$,
(35) $\quad\left\|\left\{\Psi_{N}(E[T(Y / n)])\right\}^{n} f-T(\eta x) f\right\|$

$$
\begin{aligned}
& =\left\|\left\{I+\eta\left[I-T\left(x_{1} / n, \ldots, x_{m} / n\right)\right]\right\}^{-n} f-T(\eta x) f\right\| \\
& \leq K \omega_{2}(T f, 1 / \sqrt{n}) \rightarrow 0 \quad(n \rightarrow \infty) .
\end{aligned}
$$

Example 7. In Theorem 3, take $p=q=2$, and $N_{\tau}$ to be the Poisson process $\left(\tau \in \mathbb{R}_{+}\right)$:

$$
P\left(N_{\tau}=k\right)=e^{-\eta \tau} \frac{(\eta \tau)^{k}}{k!} \quad \text { for all } k \in \mathbb{Z}_{+}^{m}, \text { where } \eta>0 \text { is a parameter. }
$$

Consider $X \equiv\left(x_{1}, \ldots, x_{m}\right)=x \in \mathbb{R}_{+}^{m}$. Then

$$
E\left(N_{\eta}\right)=\eta \tau, \quad \Psi_{N_{\tau}}(s)=e^{(s-1) \eta \tau}, \quad \Psi_{\bar{X}}^{*}(\delta)=e^{\delta \bar{x}}<\infty .
$$

Furthermore, note that

$$
\begin{aligned}
d_{1} & =\limsup _{\tau \rightarrow \infty} \Psi_{N_{\tau}}\left(\Psi_{\bar{X}}^{*}\left(\frac{2 \omega}{\tau}\right)\right)=\limsup _{\tau \rightarrow \infty} \exp \left[\left(e^{\frac{2 \omega}{\tau} \bar{x}}-1\right) \eta \tau\right] \\
& \leq \limsup _{\tau \rightarrow \infty} \exp \left[\eta \tau \frac{2 \omega}{\tau} \bar{x} e^{(2 \omega / \tau) \bar{x}}\right]<\infty \\
d_{2} & =\limsup _{\tau \rightarrow \infty} \tau\left\{E\left[\left(\frac{1}{\tau} N_{\tau}-\eta\right)^{4}\right]\right\}^{1 / 2}=\limsup _{\tau \rightarrow \infty} \tau\left(3 \frac{\eta^{2}}{\tau^{2}}+\frac{\eta}{\tau^{3}}\right)^{1 / 2}<\infty
\end{aligned}
$$

and

$$
\begin{aligned}
d_{3} & =\limsup _{\tau \rightarrow \infty} \Psi_{N_{\tau}}^{*}\left(\frac{2}{e^{2}(\sqrt{\tau} \delta-1)^{2}} e^{\delta \bar{x}} \Psi_{\bar{X}}^{*}(\delta)\right) \\
& =\limsup _{\tau \rightarrow \infty} \exp \left\{\left(\exp \left[\frac{2}{e^{2}(\sqrt{\tau} \delta-1)^{2}} e^{2 \delta \bar{x}}\right]-1\right) \eta \tau\right\} \\
& \leq \limsup _{\tau \rightarrow \infty} \exp \left\{\frac{2}{e^{2}(\sqrt{\tau} \delta-1)^{2}} e^{2 \delta \bar{x}} \exp \left[\frac{2}{e^{2}(\sqrt{\tau} \delta-1)^{2}} e^{2 \delta \bar{x}}\right] \eta \tau\right\}<\infty .
\end{aligned}
$$

So by (24) of Theorem 3 there exists a constant $K=K\left(\delta, M, \omega, d_{1}, d_{2}, d_{3}\right)$ such that for sufficiently large $n$ we have
(36) $\quad\left\|\Psi_{N_{\tau}}(E(T(X / \tau))) f-T(\eta x) f\right\|$

$$
\begin{aligned}
& =\left\|\exp \left[\eta \tau\left(T\left(x_{1} / \tau, \ldots, x_{m} / \tau\right)-I\right)\right] f-T(\eta x) f\right\| \\
& \leq K \omega_{2}(T f, 1 / \sqrt{\tau}) \rightarrow 0 \quad(\tau \rightarrow \infty)
\end{aligned}
$$
