On Toeplitz operators associated with strongly pseudoconvex domains

Abstract. Let Ω be a strongly pseudoconvex domain with smooth boundary in C^n , n>2, and let $H^2(\delta\Omega)\subset L^2(\delta\Omega)$ be the closure of the space of boundary values of holomorphic functions which extend smoothly to $\overline{\Omega}$. We show that the C^* -algebra of all Toeplitz operators on $H^2(\delta\Omega)$ with continuous symbol contain the ideal of compact operators, and modulo this ideal is isomorphic to $C(\delta\Omega)$. We also improve a result of Janas on Toeplitz operators acting in the interior of Ω .

Introduction. Let Ω be a strongly pseudoconvex domain with smooth boundary in C^n . Toeplitz operators associated with Ω were first considered by Venugopalkrishna [9], who concerned himself with operators with continuous symbol on the space $H^2(\Omega)$ of square integrable functions holomorphic in Ω . Coburn [2] considered the special case where Ω is the unit ball in C^n ; he worked with the C^* -algebras $\mathcal{F}(\Omega)$ and $\mathcal{F}(\delta\Omega)$ generated by Toeplitz operators with continuous symbol acting respectively on $H^2(\Omega)$ and on $H^2(\delta\Omega)$, the Hardy space of square integrable boundary values of holomorphic functions. He showed that both $\mathcal{F}(\Omega)$ and $\mathcal{F}(\delta\Omega)/\mathcal{F}$ are isomorphic to $C(\delta\Omega)$. Janas [7] has for general Ω identified modulo the compact operators the C^* -algebra of $B(H^2(\Omega))$ generated by Venugopalkrishna's operators.

In this note we consider Toeplitz operators on $H^2(\delta\Omega)$, the closure in $L^2(\delta\Omega)$ of the boundary values of holomorphic functions in Ω which extend smoothly to Ω . In §1 we consider the tangential Cauchy–Riemann operator δ_b , and observe that Venugopalkrishna's arguments apply in our setting. In §2 we discuss the C^* -algebra $\mathcal{F}(\delta\Omega)$ generated by the Toeplitz operators on $H^2(\delta\Omega)$ with continuous symbol; we show that $\mathcal{F}(\delta\Omega)$ contains the ideal \mathcal{K} of compact operators and that the symbol map induces an isomorphism: $\mathcal{F}(\delta\Omega)/\mathcal{K} \to C(\delta\Omega)$. Finally we answer (Theorem 3.1) a problem of Janas [7]; we show the same result holds for Toeplitz operators acting in the interior of Ω .

§1. Let Ω be a bounded domain with smooth boundary in C^n , n > 1, and let ϱ be a defining function for Ω . Let $A^q(\overline{\Omega})$ denote the space of (0,q) forms on $\overline{\Omega}$ whose coefficients can be extended smoothly to a neighbourhood of $\overline{\Omega}$, and let $C^q(\overline{\Omega})$ denote the set of $\varphi \in A^q(\overline{\Omega})$ satisfying $\delta\varrho \wedge \varphi = 0$ on $\delta\Omega$. Let \tilde{A}^q (respectively \tilde{C}^q) denote the sheaf of germs of $A^q(\overline{\Omega})$ ($C^q(\overline{\Omega})$), and let \tilde{B}^q denote the quotient sheaf \tilde{A}^q/\tilde{C}^q , which is a locally free sheaf supported on $\delta\Omega$. Let B^q denote the space of sections of \tilde{B}^q . Now $\delta: C^q \to C^{q+1}$ and so induces a quotient map $\delta_b: B^q \to B^{q+1}$. For further details see Folland and Kohn [4]. The usual inner product on $L^2(\delta\Omega)$ induces an inner product on B^q for $q \geqslant 0$; let \mathcal{L}^q denote the completion of B^q in this inner product. By δ_b^q (or simply δ_b) we shall mean the Hilbert space closure of the operator $\delta_b: B^q \to B^{q+1}$. By θ_b^q , or θ_b , we shall mean the formal adjoint of δ_b^q , which since $\delta\Omega$ is a compact manifold coincides with its Hilbert space adjoint. If T is an operator on a Hilbert space, we shall denote its domain by $\mathcal{D}(T)$. If $q \geqslant 1$, let

$$\mathscr{D}(L) = \{ f \in \mathscr{D}(\overline{\delta}_b^q) \cap \mathscr{D}(\theta_b^{q-1}) \colon \, \overline{\delta}_b f \in \mathscr{D}(\theta_b), \, \theta_b f \in \mathscr{D}(\overline{\delta}_b) \}$$

and define $Lf = (\bar{\delta}_b \theta_b + \theta_b \bar{\delta}_b) f$ for $f \in \mathscr{D}(L)$. If g = 0, let

$$\mathscr{D}(L) = \{ f \in \mathscr{D}(\overline{\delta}_b^a) : \ \overline{\delta}_b f \in \mathscr{D}(\theta_b) \},$$

and define $Lf = \theta_b \delta_b f$ for $f \in \mathcal{D}(L)$. For $g \geqslant 0$, let $\mathscr{H}^q = \{f \in \mathscr{D}(L) : Lf = 0\}$, and let $P^q \colon \mathscr{L}^q \to \mathscr{H}^q$ denote the orthogonal projection.

Our main interest is in \mathscr{H}^0 , which is just $\ker \delta_b$, and which we shall denote by $H^2(\delta\Omega)$ or just H^2 ; we shall also let $P=P^0$. Observe that since δ_b is the closure of $\delta_b\colon B^0\to B^1$, we have $\{f\in B^0\colon \delta_b f=0\}$ dense in H^2 . By [6], 2.3.2, this means that the set of smooth functions in $\delta\Omega$ with holomorphic extensions to Ω is dense in H^2 . Let σ denote the surface measure on $\delta\Omega$ and P(x,y) denote the Poisson kernel of Ω . Then Stein [8] defines $H^2(\Omega)$ to be the closed subspace of $L^2(\delta\Omega)$ consisting of those f such that

$$P[f](x) = \int_{\delta\Omega} P(x, y) f(y) d\sigma(y)$$
 for $x \in \Omega$

defines a holomorphic function P[f] in Ω . Since if f is continuous in Ω and holomorphic in Ω we have P[f] = f([8], p. 2), we have $H^2(\delta\Omega) \subset H^2(\Omega)$. Thus in particular if $f \in H^2(\delta\Omega)$, P[f] is holomorphic in Ω .

Now suppose that n > 2 and that Ω is strongly pseudoconvex. We shall quote some results which are either contained in [4], §5.4 or are

analogous to those for the operator δ in [4], §3.1. These results show that L has closed range, and that L is bounded away from 0 on $(\mathscr{H}^q)^{\perp}$. Define $G_b \colon \mathscr{L}^q \to \mathscr{L}^q$ to be the inverse of L on the range of L and zero on its complement.

Theorem 1.1. (a) If $g \geqslant 0$, G_b is bounded; if $g \geqslant 1$, G_b is compact;

- (b) For $a \in \mathcal{L}^q$, $a = LG_bL + P^q a$, and $LG_ba \perp P^q a$;
- (c) $G_b P^q = P^q G_b = 0$;
- (d) G_b commutes with δ_b and θ_b on $\mathcal{D}(\delta_b)$ and $\mathcal{D}(\theta_b)$, respectively.

For $\varphi \in C(\delta \Omega)$, let M_{φ} denote the bounded operator on $L^2(\delta \Omega)$ defined by $M_{\varphi}f = \varphi f$. By using Theorem 1.2 in place of Theorem 4.1 of [9], we can follow Venugopalkrishna's proof of [9], Theorem 2.1 to deduce that if s is smooth on Ω , then (I-P) M_s : $H^2(\delta \Omega) \to L^2(\delta \Omega)$ is compact. Now we can approximate any $s \in C(\delta \Omega)$ by smooth functions, and so we have

Theorem 1.2. If $s \in C(\delta \Omega)$, then (I-P) $M_s \colon H^2(\delta \Omega) \to L^2(\delta \Omega)$ is a compact operator.

§2. Let Ω be a strongly pseudoconvex domain in $C^n(n>2)$ with smooth boundary. For $\varphi\in C(\delta\Omega)$, let T_{φ} denote the Toeplitz operator with symbol φ defined by $T_{\varphi}f=P(\varphi f)$ for $f\in H^2(\delta\Omega)$. Let $\mathcal{F}(\delta\Omega)$ denote the C^* -subalgebra of $B(H^2)$ generated by $\{T_{\varphi}\colon \varphi\in C(\delta\Omega)\}$. We shall use the following lemma, which we were shown by Ron Douglas.

LEMMA 2.1. Let K be a closed subspace of a Hilbert space H, and let $T \in B(H)$ be normal. If K is an invariant subspace for T and the compression of T to K is normal, then K is a reducing subspace for T.

Proof. Let P denote the orthogonal projection of H onto K. It is enough to show that K is invariant for T^* ; in other words, that $PT^*P = T^*P$. Now the compression $T|_K$ of T to K is TP, and $(T|_K)^* = PT^*P$; hence $T|_K$ normal means that $TPT^*P - PT^*PTP = 0$. Now since $T(K) \subset K$ and T is normal, this implies $PT(P-I)T^*P = 0$, or $PT(P-I)^2T^*P = 0$; but this is the same as PT(P-I) = 0 which was to be proved.

THEOREM 2.2. The C*-algebra $\mathcal{F}(\delta\Omega)$ contains $\mathcal{K}(H^2)$, the ideal of all compact operators on $H^2(\delta\Omega)$, and $\mathcal{F}(\delta\Omega)/\mathcal{K}(H^2)$ is isometrically *-isomorphic to $C(\delta\Omega)$.

Proof. To show that $\mathscr{T}(\delta\Omega)$ contains $\mathscr{K}(H^2)$ it is enough to show that $\mathscr{T}(\delta\Omega)$ is irreducible and that $\mathscr{T}(\delta\Omega)$ contains at least one non-zero compact operator ([3], 5.39). Suppose that Q is a projection in $B(H^2)$ such that $T_{\varphi}Q = QT_{\varphi}$ for all $\varphi \in C(\delta\Omega)$, and let Q(1) = g. If φ is holomorphic in Ω and C^{∞} in Ω , then $\varphi g \in H^2(\delta\Omega)$ and so

$$Q\left(\varphi\right) = Q\left(T_{\varphi}(1)\right) = T_{\varphi}Q\left(1\right) = T_{\varphi}g = P\left(\varphi g\right) = \varphi g$$
 .

For all holomorphic polynomials φ and ψ , we have $(\varphi g, \psi) = (Q\varphi, \psi) = (\varphi, g\psi)$, so that $(g - \bar{g}, \bar{\varphi}\psi) = 0$. By the Stone-Weierstrass theorem the



set $\{\overline{\varphi}\psi\colon\varphi,\psi$ are holomorphic polynomials} is dense in $L^2(\delta\Omega)$ and so g is real-valued. Since $g\in H^2(\delta\Omega)$, this implies that P[g] is a holomorphic real-valued function, and so g is constant. If $Q\neq 0$, then there is some non-zero $f\in H^2(\delta\Omega)$ such that f=Qf. For every φ holomorphic in Ω and C^∞ in $\overline{\Omega}$ we have $(Qf,\varphi)=(gf,\varphi)$ so that Qf=gf; then gf=f and so g=1. It then follows that Q=I and $\mathscr{F}(\delta\Omega)$ is irreducible. If $\varphi,\psi\in C(\delta\Omega)$, then on $H^2(\delta\Omega)$ $T_{\varphi}T_{\varphi}-T_{\varphi \psi}=PM_{\varphi}(P-I)M_{\psi}$, and so is compact by Theorem 1.2; in particular, $T_{\varphi}T_{\varphi}^*-T_{\varphi}^*T_{\varphi}$ is compact for each $\varphi\in C(\delta\Omega)$. Now suppose there are no non-zero compact operators in $\mathscr{F}(\delta\Omega)$. Then T_{z_1} is normal; but T_{z_1} is the compression of $M_{z_1}\in B(L^2(\delta\Omega))$ to $H^2(\delta\Omega)$, and so by Lemma 2.1 H^2 is invariant for $M_{z_1}^*=M_{\overline{z}_1}$. But this implies $\overline{z}_1\in H^2(\delta\Omega)$ which is false since $P[\overline{z}_1]=\overline{z}_1$ is not holomorphic in Ω . Thus there is a non-zero compact operator in $\mathscr{F}(\delta\Omega)$ and $\mathscr{K}(H^2)\subset \mathscr{F}(\delta\Omega)$.

Define $T: C(\delta\Omega) \to \mathcal{F}(\delta\Omega)/\mathcal{K}(H^2)$ by $T(\varphi) = T_{\omega} + \mathcal{K}(H^2)$; clearly, Tis *-linear. We shall prove that T is an isomorphism. We have already seen that $T_{\varphi}T_{\psi}-T_{\varphi\psi}$ is compact for every φ , $\psi\in C(\delta\Omega)$; hence T is a homomorphism and so is also surjective. It remains to show T is injective, or, equivalently, that T_{σ} compact implies $\varphi=0$. Suppose that T_{σ} is compact and that $\varphi(x_0) \neq 0$ for some $x_0 \in \partial \Omega$. It follows from [5], p. 275 that we can find a function f holomorphic in a neighbourhood of $\overline{\Omega}$ such that $|f(x_0)| = 1$ and |f(x)| < 1 for all $x \in \overline{\Omega} \setminus \{x_0\}$. Let $\{U_m\}$ be a neighbourhood base at x_0 in $\delta\Omega$; by adjusting f we can find holomorphic functions g_m such that $|g_m(x_0)| > 1$ and $|g_m| < 1$ in $\delta \Omega \smallsetminus U_m$. Let $n_m \in N$ be such that $|g_m^{n_m}| < 1/m$ in $\delta \Omega \setminus U_m$ and $||g_m^{n_m}|| \geqslant 1$, and define $f_m = g_m^{n_m}/||g_m^{n_m}||$. On the complement of any open neighbourhood of $x_0, f_m \rightarrow 0$ uniformly; hence $\|T_{\alpha}f_m-\varphi(x_0)f_m\|\to 0$ as $m\to\infty$. Without loss of generality we may assume that there is some g in the unit ball of H^2 with $f_m \rightarrow g$ weakly; since T_{σ} is compact, this implies $T_{\sigma}f_{m} \rightarrow T_{\sigma}g$ in norm. Now a standard argument shows that $T_{\sigma}g=\varphi(x_0)g$, and it follows that $|\varphi(x_0)|\,||f_m-g||\to 0$ as $m\to\infty$. Since $\varphi(x_0) \neq 0$, we have $||f_m - g|| \to 0$ as $m \to \infty$, and so in particular ||g|| = 1. But a subsequence of $\{f_m\}$ must converge to g pointwise a.e., and so g=0 a.e. This is nonsense, and so $\varphi=0$ on $\delta\Omega$ as required.

COROLLARY 2.3. Let $\varphi \in C(\delta\Omega)$. Then T_{φ} is a Fredholm operator if and only if φ is invertible in $C(\delta\Omega)$.

We observe that the analogous results for Toeplitz operators with symbol in $C(\delta\Omega,M_r(C))$ can be obtained by tensoring the short exact sequence

$$0 \rightarrow \mathcal{K}(H^2) \rightarrow \mathcal{F}(\delta \Omega) \rightarrow C(\delta \Omega) \rightarrow 0$$

with the C^* -algebra $M_r(C)$ of complex $r \times r$ matrices.

§3. Again let $\Omega \subset C^n$ (n>1) be a strongly pseudoconvex domain with smooth boundary. Let $H^2(\Omega)$ denote the closed subspace of $L^2(\Omega)$

consisting of the functions holomorphic in Ω , and let $P \colon L^2(\Omega) \to H^2(\Omega)$ be the orthogonal projection. If $\varphi \in C(\overline{\Omega})$, define $S_{\varphi} \in B(H^2(\Omega))$ by $S_{\varphi f} = P(\varphi f)$, and let $\mathscr{F}(\Omega)$ denote the C^* -algebra of $B(H^2(\Omega))$ generated by $\{S_{\varphi} \colon \varphi \in C(\overline{\Omega})\}$.

THEOREM 3.1. The C^* -algebra $\mathcal{F}(\Omega)$ contains the ideal $\mathcal{K}(H^2(\Omega))$ of compact operators and $\mathcal{F}(\Omega)/\mathcal{K}(H^2(\Omega))$ is isometrically *-isomorphic with $C(\delta\Omega)$.

Proof. That $\mathcal{F}(\Omega)$ contains all the compact operators has been shown by Janas [7], Theorem 1.1 (a). Define $S: \mathcal{F}(\Omega)/\mathcal{K}(H^2(\Omega)) \to C(\delta\Omega)$ by $S(S_{\varphi}+K)=\varphi|_{\delta\Omega}$. To show that S is well-defined it is enough to show that if S_{φ} is compact, then $\varphi|_{\delta\Omega}=0$; this can be done by using peak functions exactly as in the proof of Theorem 2.2. Using [9], Theorem 2.1 in place of our 1.2, we have as before that $S_{\varphi}S_{\varphi}-S_{\varphi\varphi}$ is compact for $\varphi, \psi \in C(\overline{\Omega})$, so that S is a homomorphism (Janas observed in [7] that the condition that $S|_{\delta\Omega}$ be non-vanishing in [9], Theorem 2.1 is unnecessary). Clearly S is onto, and it is injective by a simple extension of [9], Theorem 2.3, which completes the proof.

We observe that by tensoring this result we obtain the corresponding result for operators with matrix-valued symbols. This result was originally obtained by Janas ([7], Theorem 2.1) under the additional hypothesis that the analytic polynomials are dense in the algebra $A(\Omega)$ of functions continuous in Ω and holomorphic in Ω .

In the language of Brown, Douglas and Fillmore [1], we have shown that $\mathcal{F}(\delta\Omega)$ and $\mathcal{F}(\Omega)$ both define extensions of $C(\delta\Omega)$ by the ideal of compact operators on a separable Hilbert space. This raises an obvious question: do we get equivalent extensions? The answer is yes when Ω is the unit ball in C^n , as is shown by Coburn [2]. Whether the result is true in general we do not know; computations for some specific examples (in the same spirit as Coburn's) give the same answer, and we conjecture that the result is true in general.

A remark on Edgar's extremal integral representation theorem

Abstract. It is proved that if K is a closed, bounded, convex subset of a Banach space with the Radon-Nikodym property, then for every $x \in K$ there is a Borel probability measure μ on K, supported by a "separable extremal set" such that x is the barycenter of μ .

In [4], G. A. Edgar has proved a very nice version of Choquet's theorem [7] for separable, closed, bounded, convex subsets of Banach spaces with the Radon-Nikodym property. Namely, he proved that if K is a separable, closed, bounded, convex subset of a Banach space with the Radon-Nikodym property, then for every $y \in K$ there is a probability measure μ on the universally Borel measurable sets in K such that

$$y = \int_K x \, d\mu(x),$$

and the set of extreme points of K has μ -measure 1. His brilliant proof is based on the Kuratowski-Ryll-Nardzewski selection theorem and Chatterji's theorem on the convergence of bounded martingales in Banach spaces with the Radon-Nikodym property.

In [5], the same author has generalized his previous result to the nonseparable case. He defined, for universally Borel, separable supported probability measures on a fixed closed, bounded, convex subset K of a Banach space with the Radon–Nikodym property, an order relation \prec in such a way that $\mu_1 \prec \mu_2$ means, roughly speaking, that the support of μ_2 is closer to the set of extreme points of K than the support of μ_1 . He proved that for any $y \in K$ there is a measure maximal with respect to the order relation and such that (1) holds. In such a setting the result and, what is more important, its proof becomes much more complicated than in the separable case.

Below, we present an equivalent version, and we hope — an easier one, of Edgar's nonseparable theorem on extremal integral representation. But there are delicate points in the problem which are worth mentioning in advance. Namely,
